## Dog Release Form (Service-Trained & Domestic Pet)

As a registered Aloha Suites guest who wishes to have my dog, service-trained or domestic pet (hereafter referred to as dog) in my room, I agree to the following:

- Maximum of 2 dogs per room, not to exceed 50 pounds each.
- All guests with a dog staying at Aloha Suites of Lake Travis, LLC, must have a valid credit card on file at the front desk.
- My dog must have valid vaccinations for rabies and proof must be shown upon demand. See page 2 for our specific dog policy.
- I understand and approve a one-time non-refundable charge of \$25.00 per pet.
- I will be responsible for the repair or replacement of any items stained or damaged by my dog above and beyond the refundable deposit of \$100.00.
- I will be responsible for any injury inflicted upon any Aloha Suites of Lake Travis employee or guest by my dog.
- I will be responsible for bagging my dogs waste in and around the property areas and will use the exterior trash receptacles or the dumpster for disposal.
- I understand that Aloha Suites of Lake Travis may remove my dog from my room at my expense if my dog is left unattended, and I will be required to immediately vacate the premises with no refund.
- Neither Aloha Suites of Lake Travis nor any of its employees shall be responsible for the safety or well-being of my dog.
- My dog is not permitted in any unit not designated as a dog unit.
- I will keep my dog on a leash at all times while in public areas outside the unit.

Noise/Disruptive Complaints – barking and growling at other guests at the Aloha Suites of Lake Travis is not acceptable. Upon receipt of two (2) noise or disruptive complaints, I will be asked to immediately vacate the premises with no refund.

I understand that an employee of Aloha Suites of Lake Travis will inspect my room during and upon my departure from the units and assess the room for any damages. Charges may be posted following check-out. If everything is in order, your \$100.00 deposit will be refunded within 5-10 days of your stay.

Indemnify Aloha Suites of Lake Travis, LLC, and staff to include attorney fees, judgments, settlements and/or claims relating to personal injuries and property damage to any owners, guests, invitees, licensees and/or directors, officers, contractors, employees and agents of Aloha Suites of Lake Travis, LLC.

**ALOHA SUITES OF LAKE TRAVIS DOG (SERVICE-TRAINED AND DOMESTIC DOG)  
POLICY (THESE RULES ARE SUBJECT TO CHANGE AT ANY TIME)**

We assign specific rooms for renters bringing their dog, service-trained or domestic, (hereafter referred to dog). The dog must be in a crate if owner is absent or housekeeping or maintenance assistance is required at any time during the stay. Do not allow your dog on the furniture. Please take your dog with you when you leave the room for any period of time. Have your dog on a leash and keep them on the leash for your safety and ours, before opening the door or letting them out. Please pick up your dog's droppings. We have plastic bags for that purpose. Just ask at the office. In addition to the \$100 deposit, there is a non-refundable \$25.00 fee per pet. The \$100.00 is collected for damages, but is not limited to this amount. The deposit is kept until we inspect the room and advise if any damage has occurred (stains, urine, chewing or other dog related damage). If everything is in order your \$100.00 deposit will be refunded within 5-10 days of your stay.

Dogs and owners are allowed with proper training and adherence to these rules. We have no control of other dog owners from other units in the area. But if you observe a dog that does not fit within our policy we can mention it to the dog owner and our Homeowners organization and they can take appropriate action. Aloha Suites reserves the right to refuse accommodations to any pet deemed unacceptable. Thank you for your cooperation and understanding.
